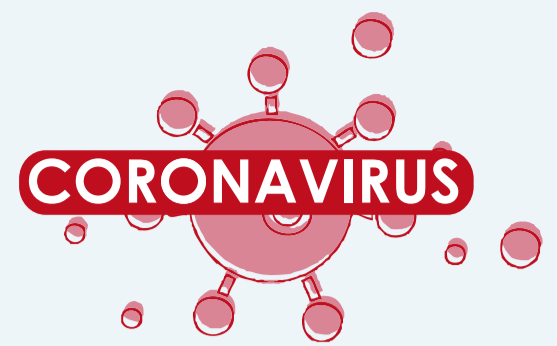




FURTHER RESTRICTIONS FOR COMMERCIAL AND PRODUCTIVE ACTIVITIES

VALID from MARCH 12 to MARCH 25, 2020



- 1** SUSPENSION OF RETAIL TRADE ACTIVITIES, EXCEPT FOR FOOD AND OTHER BASIC NECESSITIES AND ESSENTIAL GOODS, AS LISTED IN THE ANNEX
- 2** CLOSURE OF MARKETS, EXCEPT FOR GROCERY STORES
- 3** NEWSPAPER KIOSKS, TOBACCO SHOPS, PHARMACIES AND DRUGSTORES WILL REMAIN OPEN

IN ANY CASE, THE INTERPERSONAL DISTANCE OF ONE METRE MUST BE GUARANTEED

- 4** CATERING ACTIVITIES (BARS, PUBS, RESTAURANTS, ICE-CREAM SHOPS, PASTRY SHOPS) MUST STAY CLOSED
- 5** FOOD HOME DELIVERY IS ALLOWED, IN COMPLIANCE WITH HYGIENE STANDARDS ABOUT PACKAGING AND TRANSPORTATION (DPR 327/1980)
- 6** FOOD AND DRINK STORES LOCATED IN STREETS' AND HIGHWAYS' SERVICE AREAS, AS WELL AS IN RAILWAYS, AIRPORTS, LAKES AND HOSPITALS WILL REMAIN OPEN
- 7** THE FOLLOWING SERVICES WILL BE WORKING:
 - LAUNDRIES AND CLEANING SERVICES FOR TEXTILES AND FURS
 - INDUSTRIAL LAUNDRIES
 - OTHER LAUNDRIES; DRY CLEANERS
 - FUNERAL HOME SERVICES
- 8** BANKING, FINANCIAL AND INSURANCE SERVICES SHALL REMAIN GUARANTEED
- 9** AGRICULTURE AND ZOOTECHNIC ACTIVITIES, INCLUDING THOSE ONES PROVIDED BY SUPPLIERS, SHALL REMAIN GUARANTEED
- 10** TOWN HALLS' OFFICES WILL CONTINUE PROVIDING ESSENTIAL SERVICES AND EMERGENCY MANAGEMENT
